Notice is given that THE KENT COUNTY COUNCIL acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 3, 4, 5, 19, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), the Traffic Management Act 2004 and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

The effect of the made Order will be to introduce waiting restrictions (DYL means double yellow lines "no waiting at any time" restrictions) on the following length of roads:-

## Roads in the Borough of Ashford

**Atherfield Drive, Ashford – (1)** The introduction of a residents Permit Parking Area (Zone C, 24 hours per day) **(2)** The introduction of 14.1m of DYL on the northeastern side of the junction with Hythe Crescent **(3)** The introduction of 14.9m of DYL on the northwestern side of the junction with Hythe Crescent **(4)** The introduction of 12.8m of DYL on the northeastern side of the junction with Pavillion View **(5)** The introduction of 12.7m of DYL on the northwestern side of the junction with Pavillion View **(6)** The introduction of 14.5m of DYL on the southwestern side opposite the junction with Pavillion View **(7)** The introduction of 14m of DYL on the northeastern side of the junction with Romney Crescent **(8)** The introduction of 15.1m of DYL on the northern side of the junction with Romney Crescent

**Romney Crescent, Ashford – (1)** The introduction of a residents Permit Parking Area (Zone C, 24 hours per day) **(2)** The introduction of 21.3m of DYL between no.24 and no.20 **(3)** The introduction of 10.6m of DYL on the northern side of the junction with Pavillion View **(4)** The introduction of 18.5m of DYL on the southwestern side of the junction with Pavillion View

**Hythe Crescent, Ashford – (1)** The introduction of a residents Permit Parking Area (Zone C, 24 hours per day) **(2)** The introduction of 10.4m of DYL on the eastern side of the junction with Pavillion View **(3)** The introduction of 19.1m of DYL on the southeastern side of the junction with Pavillion View **(4)** The introduction of 32m of DYL on the eastern side between no.7 and no.3

**Pavillion View, Ashford – (1)** The introduction of a residents Permit Parking Area (Zone C, 24 hours per day) **(2)** The introduction of 9.2m of DYL on the southeastern and northwestern sides of the road between no.2 and no.4.

The Order was made on 24/02/2025 and its provisions will come into effect on the same day.

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1, 2, 3, 4, 5, 19, 32, 35, 36, 45, 46, 49, 51, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on the 24<sup>th</sup> day of February 2025 and may be cited as "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 (Amendment No.17) Order 2025" ('this Order')
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023" ('the Order of 2023') shall have effect as though:

(a) Schedule 2 to the Order of 2023 is amended by the replacement or issue of the following Map Tiles:

ET121 revision 0 replaced by	ET121 revision 1
ET122 revision 1 replaced by	ET122 revision 2

(b) In Schedule 3 to the Order of 2023 the following Table below shall be added to the Schedule in the correct alphabetical sequence:-
