The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1, 2, 3, 4, 5, 19, 32, 35, 36, 45, 46, 49, 51, 53, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ('the Act') and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby propose to make the following Order:-

1. This Order shall come into operation on the day of 2024 and may be cited as "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 (Amendment No.10) Order 2024" ("this Order")
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023" ("the Order of 2023") shall have effect as though:
 - (a) Schedule 2 to the Order of 2023 is amended by the replacement or issue of the following Map Tiles:

ET120 revision 0 replaced by ET120 revision 1

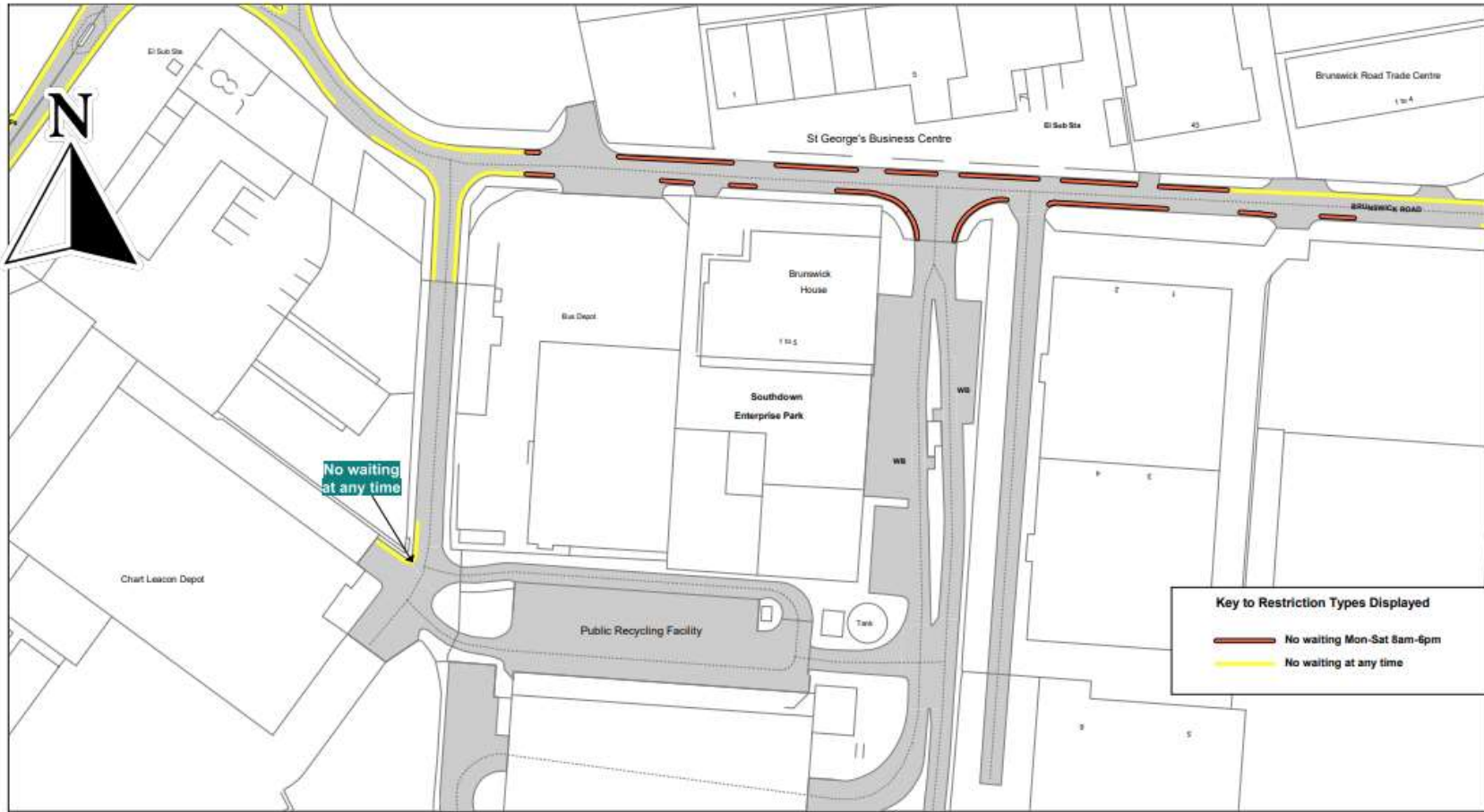
