## NOTICE OF SUBMISSION OF ASHFORD LOCAL PLAN TO 2030

**Notice is hereby given, in accordance with the Planning and Compulsory Purchase Act 2004 and Regulation 22(3) of the Town and Country Planning (Local Planning) (England) Regulations 2012, that Ashford Borough Council has submitted the Local Plan 2030 to the Secretary of State for Communities and Local Government on 21st December 2017, for independent examination.**

Ashford Borough Council has prepared a new Local Plan for the borough, which sets out the land that needs to be provided in the borough to accommodate new homes and jobs up to 2030. In addition to site allocations, the Local Plan 2030 establishes planning policies and guidance to ensure local development is built in accordance with the principles of sustainable development.

The Publication Version of the Local Plan 2030 was published in June 2016 and subsequent 'Main Changes' in July 2017, for 8 week public consultations. Following this, the Council has decided to proceed with the formal submission of the Local Plan for independent examination in public.

### Examination in Public

The Ashford Local Plan 2030 will now be subject to an examination to be conducted by an Independent Inspector, appointed by the Planning Inspectorate. All parties who made representations (comments) on the plan at either stage of public consultation will be contacted directly, with more information, in due course.

Part of the process will involve hearing sessions where those invited to attend will have the opportunity to respond to matters raised by the Inspector. Please note invitation to participate is coordinated through the Planning Inspector and the Programme Officer, both of whom are independent from Ashford Borough Council. Information such as the hearing schedules and agendas will also be made available on the council's website when available.
