You will see that from 262 units there were (as at Spring 2016) 88 primary pupils (PPR of 0.34) and 45 secondary pupils (PPR of 0.17).

It would be useful to know the breakdown of types of units on the site at that time to get more of an idea about what these figures represent.

Kayleigh and I will produce this analysis each time you send us a site request, so that over time we will build up a strong evidence-base where we have tracked sites over time to see how they evolve. The main thing is to have the completion info (no. of units etc.) at the same point in time (as near as possible!) to the Census dates of January and October.

I am not sure if the map is sufficient, but it has street names - can we use this to identify when and how many children moved in - or rather when they got added to the pupil census. At present we only have mod year estimate to 2015, but pupil census for the site up to 2016 would be great.

Can you let me know is this enough information to get pupils numbers, if not we'll have to get post codes or something.
