Road Traffic Regulation Act 1984

Notice is given that THE KENT COUNTY COUNCIL acting as the Local Traffic Authority and in exercise of its powers under Sections 1, 2, 32, 35, 36, 45, 46, 47, 49, 53, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), the Traffic Management Act 2004 and all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby proposed to make the following Order:-

The effect of the made Order will be to introduce waiting restrictions (DYL means double yellow lines "no waiting at any time" restrictions) on the following length of roads:-

#### **Roads in the Borough of Ashford**

**Mead Road:** (1) On the southwestern side of Mead Road extending 22.8 meters on to the western side of Bath Road (2) On the northeastern side of Mead road between the building line of numbers 37 & 35 for a distance of 30.8 meters to the building line of numbers 27 & 25 (3) From the side of 22 Mead Road on Bath Road for a distance of 88.5 meters on Mead Road to Canterbury Road (4) On the northeastern side of Mead Road outside number 1 for a distance of 17.5 meters to the junction of Canterbury Road.

**Canterbury Road:** (1) On the northwestern side of Canterbury Road between number 27 for a distance of 25m to the junction of Mead Road (2) On the southeastern side of Canterbury Road between number 27 for a distance of 59 meters to the existing DYL (3) On the northwestern side of Canterbury Road extending in a northeasterly direction for 287 meters to the junction of Shangri La.

**Boys Hall Road:** (1) On the northwestern side of Boys Hall Road from Shangri La extending 45 meters in a northeasterly direction (2) On the southeastern side of Boys Hall Road extending 226 meters in a northerly direction.

**Paper Lane:** (1) The removal of 30 meters of DYL to allow additional parking capacity (2) Junction protection markings (4 meters) on the eastern side of paper lane (3) Junction protection markings (7.5 meters) on the southeastern side of Paper Lane,

1. This Order shall come into operation on the            day of            2024 and may be cited as "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023 (Amendment No.16) Order 2024" ("this Order")
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Kent County Council (Various Roads, Ashford) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2023" ("the Order of 2023") shall have effect as though:
